Claims for transit damage or missing parts must be notified to Guard-M8 within 3 working days of delivery, supported by appropriate images and documentation.

## Warranty Scope

During the warranty period, Guard-M8 will, where a valid warranty claim is confirmed, repair or replace defective components or, where appropriate, the complete unit. Any repair or replacement will be determined following assessment by Guard-M8's appointed engineers.

Warranty coverage for replacement parts or components will expire in line with the original warranty period and will not extend or renew the original warranty duration.
